All members must complete and sign this form prior to operating any Blackbushe Aviation aircraft. These Terms and Conditions are between the below named member and Blueplane Ltd (t/a Blackbushe Aviation), Blackbushe Airport Ltd, and Blinkbushe Ltd (hereafter referred to as **Blackbushe Group**)

## I agree to the following terms and conditions:

- 1. With the exception of trial lessons and experience flights, I have been provided access to the Blackbushe Aviation Training Manual and understand that I must read and comply with all the rules and regulations provided within it.
- 2. I declare that to the best of my knowledge I have no medical conditions that would affect my safety and that of others whilst participating in any aviation activities.
- 3. Blackbushe Group will not be held responsible for any loss or damage to personal belongings whilst on the premises.
- 4. Blackbushe Group will not be liable for any personal injury or death to me, or any third party except where caused by the negligence of the Blackbushe Group or its staff.
- 5. I (and any minors for whom I am responsible) for will comply with all instructions provided by both the instructors and operational staff of Blackbushe Group.
- 6. I will provide at least 24 hours' notice to cancel any booking. Cancellations within 24 hours will be charged at £50.
- 7. Payment is required in advance of all flights without exception.
- 8. I understand that all money paid for packages or trial lessons are non-refundable and non-transferrable.
- 9. All trial lessons, or packages will expire and be forfeited after 12 months from the point of purchase. Additional funds placed on account, if not used or a refund requested, will be forfeited after 12 months of inactivity.
- 10. At the discretion of Blackbushe Group, trial lessons or packages, may be extended for up to 6 months, subject to:
  - a. an administration fee of £35 for trial lessons, or £100 for all other packages; and
  - b. recalculation of the balance in accordance with the published price list at the point of extension.

Extensions may only be requested prior to the expiry of the voucher, package or funds.

- 11. If the aircraft is owned by a third party, I agree to also be bound by their terms and conditions (available on request).
- 12. Blackbushe Group may store my personal information including training records for a period of up to 7 years in order to comply with regulations.

## ADDITIONAL TERMS FOR PRIVATE HIRERS

13. Unless operating as a student, I am liable for any insurance excess incurred as a result of any accident which I am involved in for any aircraft that I fly through Blackbushe Group. The current excesses are as follows:

S200s and PA28s	£2,500	GBOWY, GCBZR, DA40 / DA42	£4,000

- 14. I confirm that I have not been involved in an accident or incident arising in an aviation insurance claim in the last 6 years.
- 15. I have more than 70 flying hours total.
- 16. I am under 74 years of age and will notify Ops if I turn 74 during my membership so that I can be named on the insurance.
- 17. I accept responsibility for ensuring that a tech log is completed and authorised by an instructor for all flights.
